We refer to our Notice 7 issued on 5 March 2020.

Our members are reminded and urged to ensure that they engage and provide comments on the proposed draft regulations.

We further present you with the updated details on the public participation sessions and also attach it to this email.



President Cyril Ramaphosa signed the Property Practitioners Act into law in September 2019.

The Act seeks to regulate and transform the industry. However, the Department of Human Settlements has to come up with regulations which are necessary to give effect to the commencement of the Act. It is in this context that the Department is calling on Property Practitioners (Bond Originators, Auctioneers, Trusts, Property Evaluators, Assessors) and the public at large to comment on the draft regulations to be published by the Minister of Human Settlements, Water and Sanitation. To support and enhance the public comment to be received, the Department of Human Settlements will hold public information sessions in all nine provinces as outlined in the table.
