RE: THE NATIONAL ASSOCIATION OF MANAGING AGENTS // PROPERTY PRACTITIONERS REGULATORY AUTHORITY (BBBEE REQUIREMENTS FOR PROPERTY PRACTITIONERS AND SUBSEQUENT REFUSAL TO ISSUE FIDELITY FUND CERTIFICATES)

- 1. The above matter refers.
- 2. We confirm having been instructed and mandated in the matter relating to the PPRA's recent decision to impose Level 8 BBBEE requirements on Property Practitioners for purposes of obtaining a Fidelity Fund Certificate in 2025, premised upon the interpretation of Section 50(a)(X) of the Property Practitioners Act.
- 3. We are pleased to inform you on the latest developments and confirm that, following amicable consultations with the PPRA, it has been determined that, pending a final decision by the PPRA's Board after consultation with their counsel, property practitioners will no longer be required to provide confirmation of their Level 8 BEE status in order to obtain a Fidelity Fund Certificate.
- 4. The PPRA has confirmed that compliant applications will be duly considered, and Fidelity Fund Certificates will be issued to property practitioners without the need for a Level 8 BEE certificate. However, it was reiterated that a valid BEE Compliance
